Dear Friend,

As I write this letter, Christmas, the season of hope and joy, is almost here. Yet increasingly we see the face of despair. Our city is facing some of the worst times in recent memory.

Our economy is entering its first recession in over ten years. Many people are being laid off. Others face the very real threat of losing their homes.

Then, disaster on September 11 almost put us over the edge as the need for clothing, food, and counseling from Catholic Charities of Brooklyn and Queens became greater than ever. The generosity of many has helped provide for those directly affected, but now scores of other neighbors are requesting our assistance.

I want to tell you about three families for whom the holiday season will be especially tough this year:

Michelle is a sweet and lovable little girl. For her though, the holiday season is not always such a joyous time.

Her mother cannot afford any gifts and a Christmas dinner is impossible to prepare with an empty refrigerator. Michelle cannot understand why she and her mother, who comes home exhausted from her minimum wage job, have so little.

As they face another holiday with little to celebrate, her mother prays: "Dear God, who will help us"?

In another part of the city, Tony, an unemployed young father, feels the cold and bitter winter bearing down. While others celebrate with trees and lights, he worries about keeping a roof over his children's heads.


But we can't do it without the help of generous contributors like you.


