Parents who want access to information on an adult child's health, finances or college grades need the child's permission in writing.

A lot of things change when a child turns 18. But one of the biggest is also one of the most surprising to a lot of parents: Once children turn 18, parents can no longer make legal decisions for them or receive information about them that is considered private, unless they have the children's permission. And not having that permission can be particularly problematic when a child is away at college. For instance, parents can't be notified of a student's grades at college or enrollment status without written permission from the student. Parents also won't necessarily know about any bills in the student's name that are outstanding. Most disturbing, without express consent from the child, parents can't get details of their child's medical condition "and they no longer have the [legal] ability to make decisions" regarding the child's health-care treatment, says Therese R. Nicklas, a certified financial planner and president of Wealth Coach Freshman Forms Fills a Critical Need for Women Inc. in Rockland, Mass...

A COLLEGE freshman walked to a hospital emergency room at midnight and said she feared that she was going to harm herself. Twelve hours later, after it was determined that she was no longer in danger, she decided to call her parents — but only after a long conversation with a nurse at the hospital about whether she wanted to talk with family members about her experience. "It was initially a shock to realize that if this had happened the day before, we would have been called immediately," said her mother, who asked to be identified only by her middle name, Jo, to protect her daughter's privacy. Why the difference? The daughter turned 18 at midnight that night and by law had the right to keep the episode private — even from her own parents and even though they would ultimately pick up the bill...



When Jennifer Morrison learned her daughter Haley had been injured at school, she called the hospital to find out what was going on. Because Haley was 18, the hospital would not give her any information. Later, when Haley needed surgery, Jennifer had to spend hours collecting IDs and documents to prove she was next of kin – time she should have been spending with Haley and her doctors.

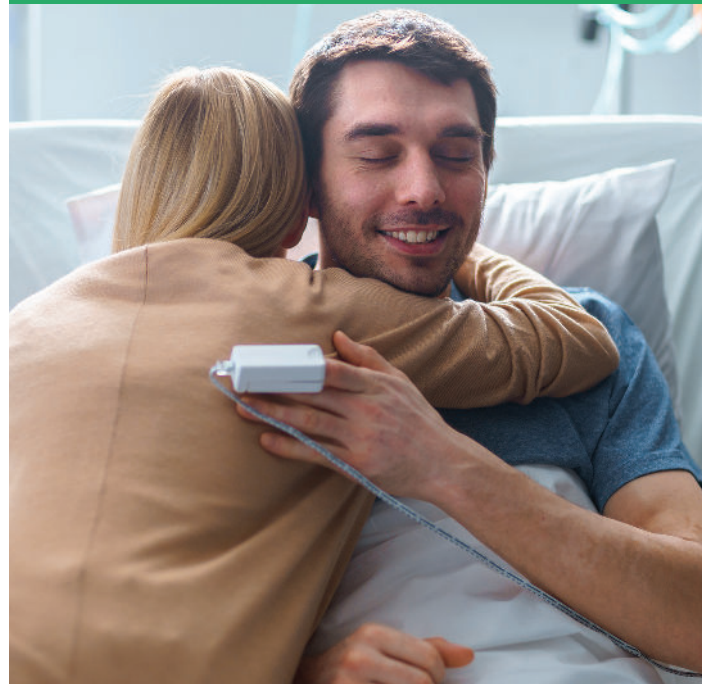
